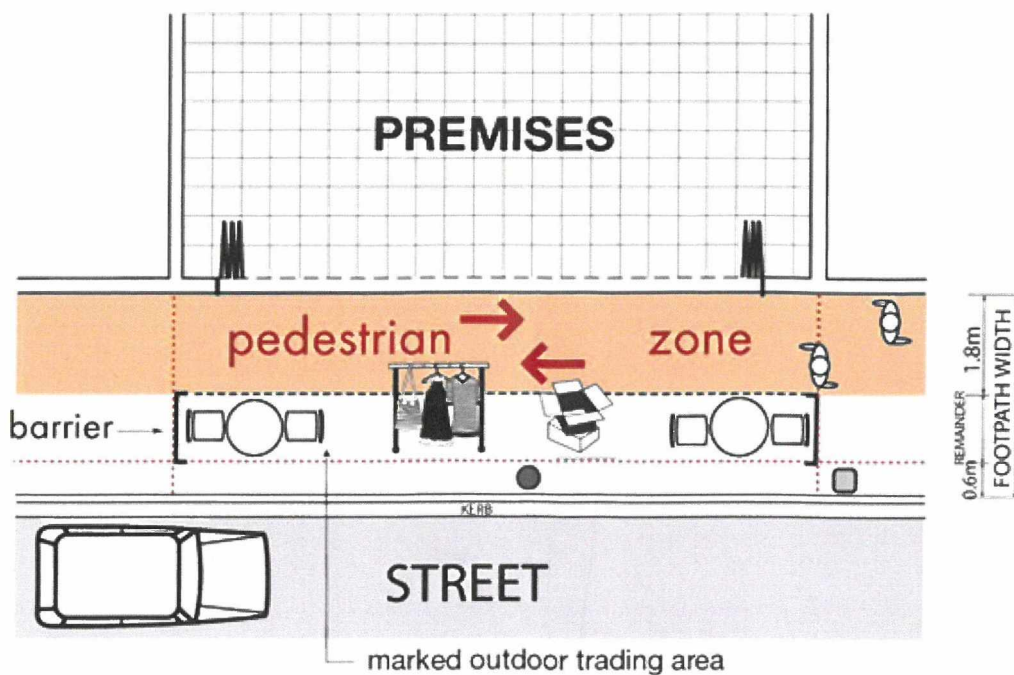
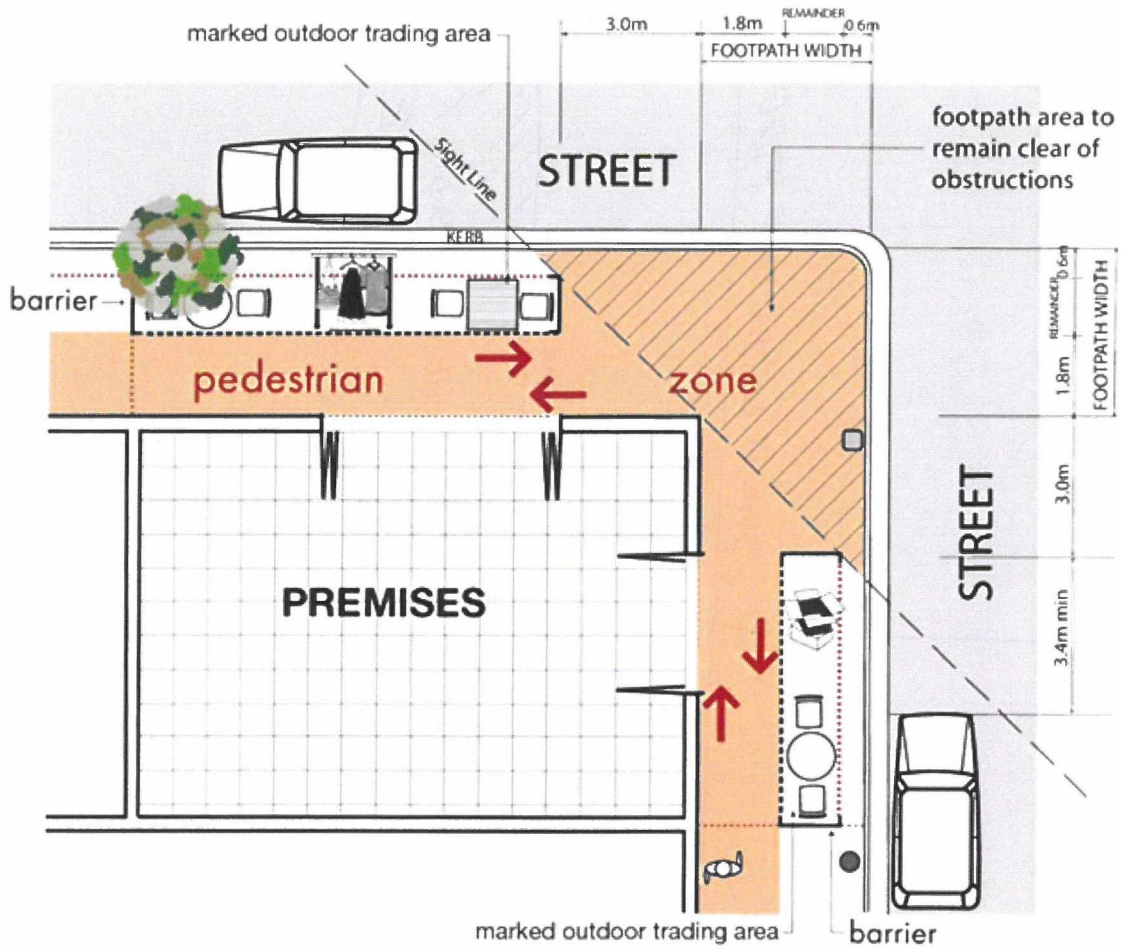


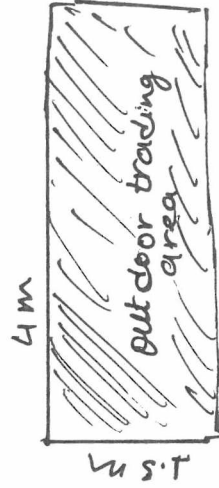

<p>Any person, during the specified submission period, may make submissions to the City of Newcastle concerning the outdoor trading application. The submissions must specify:</p> <ul style="list-style-type: none"> <li>- the application number ApplicNo2 and property address,</li> <li>- the submitter's name, residential address, contact number; and preferably an email address,</li> <li>- the disclosure of any political donations/gifts made, and</li> <li>- the reasons for support or objection of the application.</li> </ul> <p>Submissions must be made in writing and should be lodged via the <a href="#">online submission form</a> on City of Newcastle's website.</p> <p>Alternatively, submissions can be made by mail to PO Box 489, Newcastle NSW 2300 or delivered in person to the Customer Service Centre at 12 Stewart Avenue, Newcastle West NSW 2302.</p>

Submissions must be received by 5.00 pm on 8 December 2023.
