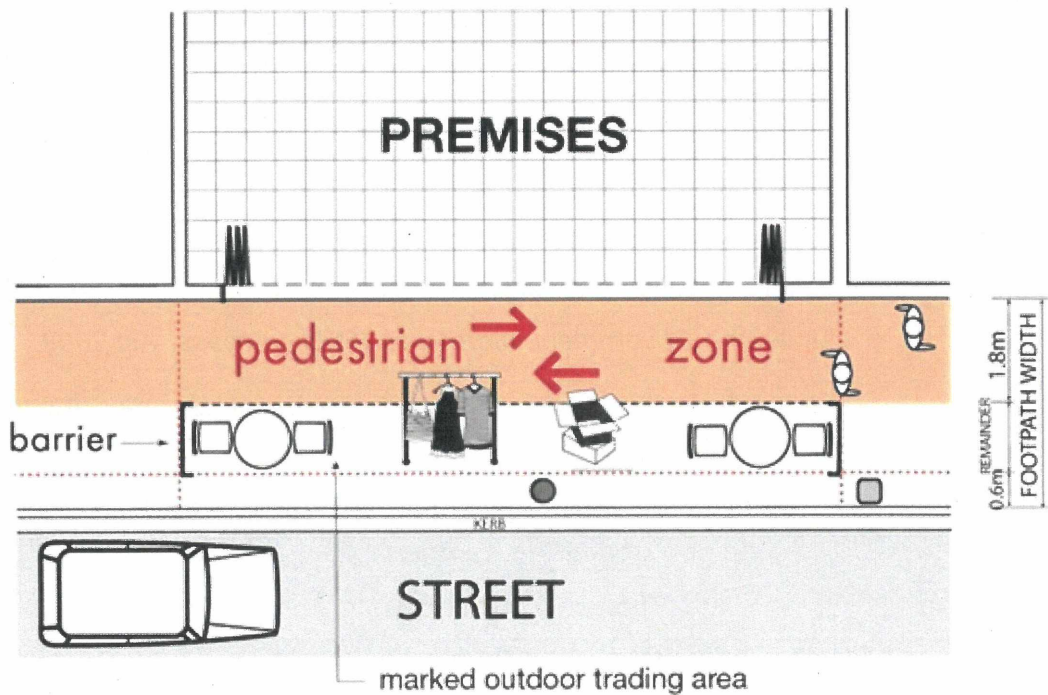
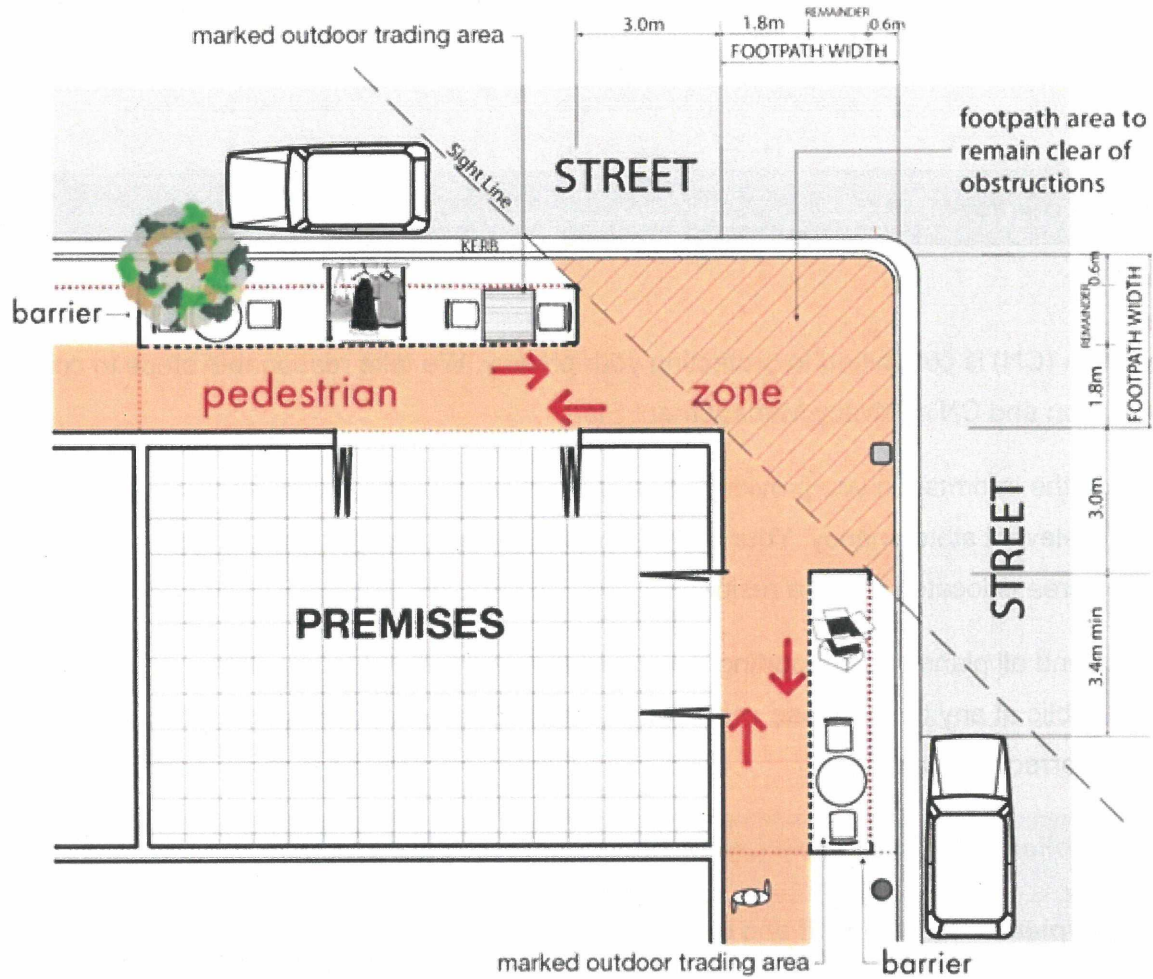

The submissions must specify:</p> <ul style="list-style-type: none"> - the application number ApplicNo2 and property address, - the submitter's name, residential address, contact number; and preferably an email address, - the disclosure of any political donations/gifts made, and - the reasons for support or objection of the application. <p>Submissions must be made in writing and should be lodged via the online submission form on City of Newcastle's website.</p> <p>Alternatively, submissions can be made by mail to PO Box 489, Newcastle NSW 2300 or delivered in person to the Customer Service Centre at 12 Stewart Avenue, Newcastle West NSW 2302.</p>

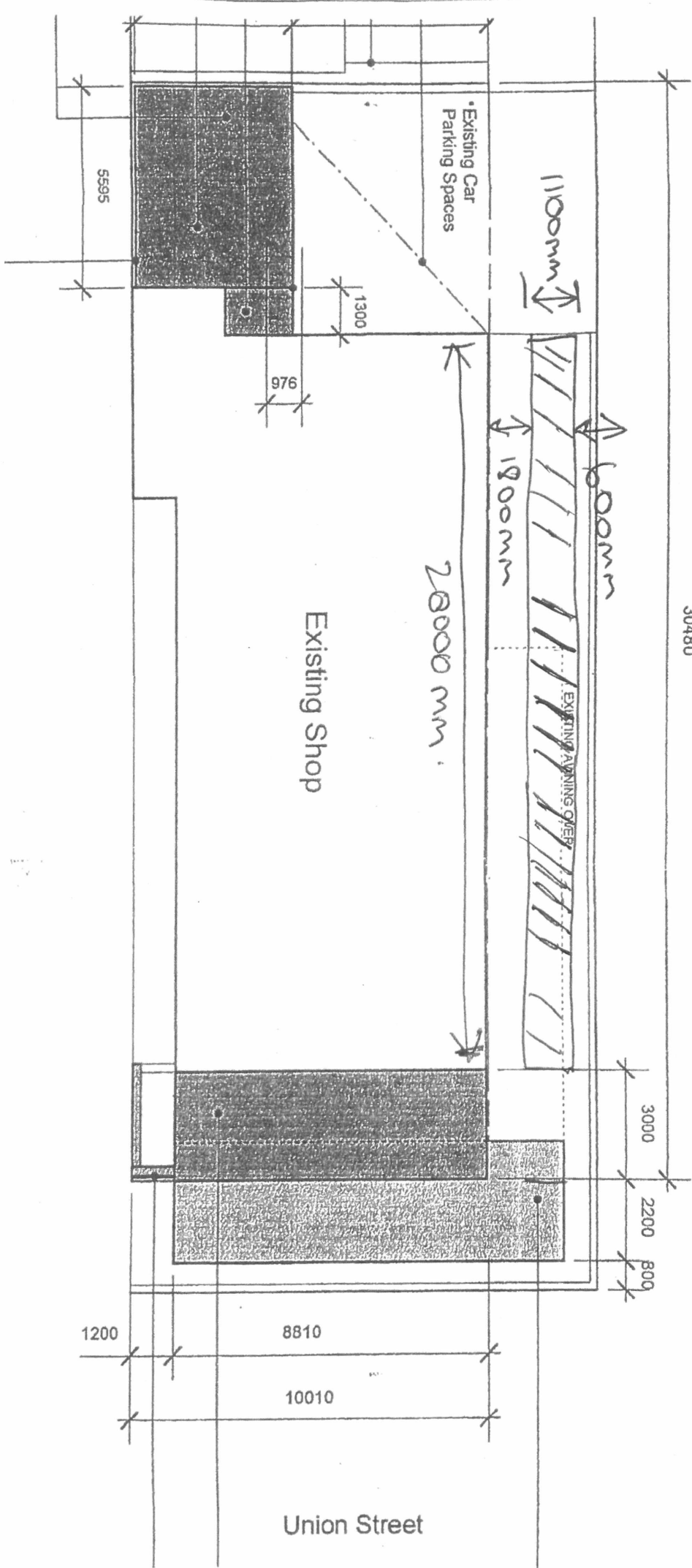
