City of Newcastle (CN) are proposing road names for one (1) new private road in Elermore Vale.


This is a new community title subdivision that has been approved as part of DA2021/00507. The subdivision includes one privately owned road and a privately owned extension to an existing public road that require to be named to facilitate addressing and to aid emergency service location and service delivery.

This development is located between two separate sections of Virgo Street, however, the approved layout of the site does not allow for Virgo Street to be extended so that it connects the two existing sections.

This proposal will not alter the house numbering or addressing of existing premises on Virgo Street.

Proposed Road Name	Name Origin	Description
Fields Way	The name comes from its location on land historically used as fields.	The road begins near the south-eastern corner of neighbouring SP77584 and continues in an eastern direction for 115 metres before splitting into a short section that continues for 17 metres in a south-eastern direction, and a one-way section that continues for 40 metres in a north-eastern direction before terminating where its intersects with Virgo Street.
Virgo Street (private extension)	Name in use.	The road extends from its existing northern section towards the south to connect with the proposed Fields Way.



#### **Submissions**

Any person, during the specified submission period, may make submissions to the City of Newcastle concerning the proposed road names. The submissions must specify:

- the grounds of objection or support;
- quote 'Elermore Vale Road Naming November 2022' in the title of the submission;
- include the submitter's name, address, and daytime contact number; and
- where possible, an email address.

**Please note**: Submissions will only be considered that directly relate to the proposed road names. Any references to the approved development are unable to be considered as part of this road naming process.

Submissions must be made in writing and submitted via e-mail or post. Where possible, City of Newcastle prefers to communicate with submitters via email to support sustainable environmental practices and improved timeliness of any correspondence.
