This is a new stage of greenfield land to be released in the coming months. These roads need to be named to facilitate addressing to aid emergency service location and service delivery. Please see the below table and attached location map (Attachment 1):

	Proposed Road Name	Name Origin	Description
1.	Arabian Street	Horse breed	Extends westward off Minmi Road to join Shetland Street
2.	Chestnut Close	Horse breed	Extends northwards from Quarterhorse Drive
3.	Clydesdale Crescent	Horse breed	Extends westward from Shetland Street, then southwards before rejoining Shetland Street
4.	Pony Close	Horse breed	Extends southward from Shetland Street
5.	Shetland Street	Horse breed	Extends southwards to join Pony Close
6.	Stallion Street	Horse breed	Extends westward from Quarterhorse Drive to Winx Way
7.	Thoroughbred Street	Horse breed	Extends northwards from Quarterhorse Drive
8.	Winx Way	Famous race horse	Extends northwards from Quarterhorse Drive
9.	Quarterhorse Drive	Horse breed	Extends eastward from Minmi Road, turning northwards to rejoin Minmi Road
