

Raised Pedestrian Crossing near Womboin Road





#### Background

Pedestrian safety on Wallarah Road has been identified as a priority due to the proximity to Lambton High School and the nearby sporting fields.

The benefits of a raised pedestrian crossing over the existing children's crossing include traffic calming and improved amenity and safety, particularly for access to and from the sporting fields. The crossing will include a lighting upgrade which will assist in activating the local area, including the New Lambton skate park.

This consultation, which is supported by the Newcastle City Traffic Committee, is being undertaken to ensure that the community is informed and has the opportunity to raise concerns.


### Proposed Pedestrian Crossing Upgrade Wallarah Road, New Lambton

#### What is proposed

We are seeking feedback on a proposal to improve pedestrian safety and amenity in your neighbourhood, at the crossing on Wallarah Road, near Womboin Road.

#### The proposed works include:

- Construction of a raised pedestrian crossing in Wallarah Road, near Womboin Road north of the location of the existing children's crossing.
- Construction of kerb extensions.
- New footpath on the west of Wallarah Road, to connect the crossing with the cycleway.
- · Upgrade of street lighting.
- · Signage and line marking.
- Tree planting on Wallarah Road.
