
City of Newcastle's (CN) current Alcohol Regulated Areas (ARA) are at their term end.

Sections 642 and 632A of the Local Government Act 1993 provide NSW Local Government's with the power to establish an Alcohol Free Zone (AFZ) and Alcohol Prohibited Area (APA) in locations where anti-social behaviour or crime has been linked to the public consumption of alcohol. AFZ can be declared in any public road or car park and include the adjoining footpaths and nature strips. Approved outdoor dining areas are exempt from AFZ restrictions. APA can be declared in any CN managed park, reserve and or beach. Once these zones and areas are established, the drinking of alcohol is prohibited at any or set times.

AFZ and APA are collectively known as ARA. The object of ARA's is as an early intervention measure to prevent the escalation of irresponsible street drinking to incidents involving serious crime. They aim to address alcohol related anti-social activity including disorderly behaviour in public places.

ARA's also aid public perceptions of an area's community safety and in turn contribute to local economic viability.

CN has approximately 170+ existing AFZ's and 37 existing APA's which are enforced by the NSW Police Local Area Command.

An independent review, prepared in consultation with NSW Police, proposes the following Alcohol Regulated Areas:

Re-establishment of CN's ARA network for a further four-year term (to 2025) including the following locations:

All Beaches and Skateparks

Newcastle City East, Newcastle City Central and Newcastle City West

Hamilton South

Darby Street and Cooks Hill

Beaumont Street, Hamilton

Stockton

Mayfield

Wallsend

Apply a precinct-based approach for the local government area (LGA) larger ARA's, with boundaries spanning several public streets or roads. For these areas, this would replace the current individual street/place-based allocation of zones and areas.

Ensure precinct perimeters are aligned to licensed premises and reflect alcohol related crime hotspots as identified by NSW Bureau of Crime Statistics and Research (BOCSAR).

Map all CN beaches and skateparks as APA's.

Key public areas not included in the proposed ARA network are playgrounds, parks and sports fields unless specifically mapped as an ARA as a result of BOSCAR data.

Improve clarity and consistency of ARA signage, and review signage locations. Ideally signs would include a map illustration of the zone and be installed at the entry to ARA precincts to reduce signage clutter.

Facilitate opportunities for picnicking by adopting timed restrictions prohibiting the public consumption of alcohol from 8pm through to 8am at the following identified key picnic spots throughout the city:

King Edward Park, Newcastle

Hunter River Foreshore, Wharf Road edge up to and including Nobby's and Horseshoe Beach.

Bar Beach Hill, Bar Beach

Stockton – Identified key streets and Hunter River Foreshore

Fort Scratchley, Newcastle East

Centennial Park, Cooks Hill

Nesca Park, Bar Beach

Civic Park, Newcastle

Foreshore Park, Newcastle East

Pacific Park, Newcastle East

Islington Park, Islington

Gregson Park, Hamilton


