PURPOSE

To adopt City of Newcastle's (CN's) Councillor Expenses and Facilities Policy.

RECOMMENDATION

That Council:

1 Adopts the Councillor Expenses and Facilities Policy at **Attachment A.**

KEY ISSUES

- Policies are key control documents for CN that mitigate risk. They are critical to supporting effective and evidence-based decision making and ensure CN complies with relevant legislation and guidelines. Policies are most effective when they are regularly reviewed and updated.
- 3 Sections 252 and 253 of the *Local Government Act 1993* (the Act) requires councils:
 - i) to adopt a councillor expenses and facilities policy within 12 months of each local government election; and
 - ii) prior to adoption, to place the policy on public exhibition for a period of at least 28 days during which submissions may be made.
- At the Council meeting held on 24 May 2022, Council resolved to place CN's draft Councillor Expenses and Facilities Policy on public exhibition for 28 days (from 25 May to 22 June 2022), as is required under section 253 of the Act.
- 5 No submissions were received during the public exhibition period and as such no changes are proposed.

FINANCIAL IMPACT

6 The expenses proposed under the Policy are included in CN's 2022/23 budget.
