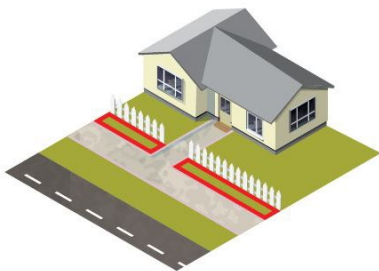
PLEASE NOTE: paved/sealed surfaces on the verge can only be excavated by City of Newcastle (CN). This is only possible if CN has a street tree scheduled to be planted in the space and is able to excavate a space around the tree at the same time. This area can then be planted and maintained by the resident. In all other circumstances planter boxes must be used to create a street garden where the verge is sealed.

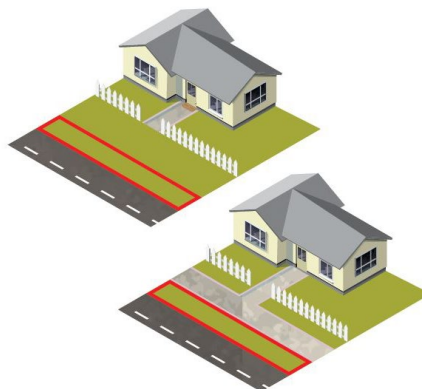

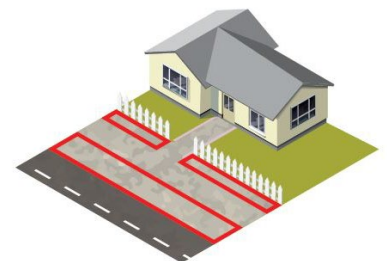

Street garden conditions

Please read the following conditions and tick to confirm that you understand them

The margin of the garden must be treadable and flush with the footpath and must not include raised edges such as brick, timber, plastic or stone surrounds, spiky plants, stakes or fencing

The garden must not create access or sightline barriers, present safety hazards for people using the footpath, nor impede access to any public utilities or facilities such as bus stops

Gardening activities, plants and equipment must not impede pedestrian access to the footpath

Planting must be carried out by hand at a depth of no more than 300mm. Mechanised tools and equipment must not be used, and care must be taken around stormwater drainage pipes and tree roots

The garden must not pose a safety risk and must be maintained in a way that does not create water, soil or mulch run-off from the garden onto the footpath, road surface or other properties

The garden must not result in the planting, pruning, damage or removal of street trees

Plants must not grow higher than 500mm tall

Groundcovers/treadable plants (nothing with any height) must be planted:

- 450mm in from the kerb
- 1000mm either side of a driveway
- 3000mm to a street corner

A minimum of 300mm must be kept clear between plants and power poles

A minimum of 1200mm footpath must be allowed for pedestrian access

Additional conditions for Planter Boxes (where applicable):

Please read the following conditions and tick to confirm that you understand them

The planter box must be constructed from untreated timber, plastic or Colorbond steel

The planter box must be between 600mm and 1200mm wide and between 600mm and 2400mm long

The planter box must be between 450mm and 600mm high (not including plants)

The planter box must maintain at least 300mm clearance to a power pole

The planter box must maintain at least 1000mm clearance either side of a driveway

The planter box cannot be constructed around (enclosing) the trunk of a street tree

The planter box must be installed above existing ground level with drainage directed to the kerb & gutter (but not across footpath surface)

The planter box should be self-wicking

Plants must not grow higher than 500mm tall (measured from the soil level of the planter box)

I understand that I will be required to cover all costs associated with the construction and ongoing maintenance of my street garden, including any damage to public infrastructure and replacement of failed or damaged plants

I am aware that if my street garden does not comply with the guidelines it may be removed by CN

I understand that street trees can only be planted or pruned by qualified CN arborists. Residents are not permitted to plant or prune a street tree themselves (requests for planting of a new tree, or maintenance of an existing tree can be lodged via our website or by phone)

I understand that I am responsible for my own safety while constructing, planting and maintaining my street garden

I understand that any children, who I am not a close relative of, that are participating in the planting and maintenance of the street garden must be accompanied by a parent or legal guardian
