Executive Summary

City of Newcastle (CN) is implementing the largest and most complex stage of the Bathers Way project – Newcastle Beach. The Bathers Way – Newcastle Beach project is divided into two stages and in late 2018 CN conducted drop-in sessions and an associated survey to present updated design plans and seek community feedback on the draft plans.

The plans for this stage cover land between King Edward Park and Newcastle Surf Life Saving Club. It includes a new skate park and bowl, exercise equipment, access improvements, new amenities, a kiosk and inclusion of a community hub in the redevelopment of the Newcastle beach pavilion.

The proposed concept plans intend to transform this section of coastline into an appealing area for the community and tourists. Detailed design for Stage 2 (subject to funding) will commence following the 2018 consultation.

In order to facilitate community engagement for this stage in the project, four drop-in sessions occurred between Thursday 6 December and Wednesday 12 December 2018. Over 70 people attended the sessions where they had the opportunity to review updated concept plans, artist impressions and speak directly with content experts.

The majority of people who attended the drop-in sessions were broadly supportive of the project as a whole. Concerns that were raised by attendees were predominantly focussed on the inclusion of the skate bowl, specifically that it is proposed to be located on the beach.

Supporting these face-to-face sessions was an online survey that was completed by 335 participants, 132 of these respondents supported the overall plans. The most supported elements were shade and seating (71%), community/recreation facilities (66%) and wider shared pathways. The skate bowl was supported (51%).

Overall the aspects that were met with opposition included the skate bowl (188 of those who opposed the overall plan) and skate park (96 respondents who opposed the overall plan).

The proposed extent to which the skate bowl extends onto the sand was considered the most concerning aspect of the design (182 respondents indicated that the skate bowl/skate park was a concern for them).

The results related to the surf pavilion show public amenities including toilets, showers and bubblers ranked as the most important to participants.

Overall, 191 responses (57%) indicated that they either strongly opposed or somewhat opposed the updated draft plan for the Newcastle Beach stage of the Bathers Way.

1 Introduction

City of Newcastle (CN) is implementing the largest and most complex stage of the Bathers Way project. This stage intends to transform this section of coastline into an appealing area for the community and tourists.

The proposed stretch between King Edward Park and Newcastle Surf Life Saving Club includes a new skate bowl, exercise equipment, access improvements, new amenities, a kiosk and inclusion of a community hub in the redevelopment of the Newcastle beach pavilion.

In order to facilitate community engagement and support for this stage in the project, four drop-in sessions occurred between Thursday 6 December and Wednesday 12 December 2018. Over 70 people attended the face-to-face sessions and over 330 participated in an online survey. The drop-in sessions were promoted through print advertising, social media channels, outdoor signage, and promotion on CN's web homepage slider, a dedicated Have Your Say engagement webpage, media release, animation and digital invite to key stakeholders.

In total, over 70 people attended the drop-in sessions and 335 people participated in the online survey.

1.1 Objectives

To:

- Gauge support for the current Bathers Way Stage 1 design
- Increase awareness, inform and provide mechanisms for people to have their say.

2 Methodology

2.1 Research approach

LGA wide print and digital advertising provided a wide reach.

This activities fall under within the *inform to consult* levels of the IAP2 spectrum endorsed in CN's Community Engagement Commitment.

The survey questions can be found in Appendix I.

2.2 Data collection

The online survey was conducted between 28 November and Friday 14 December 2018. It was made available online and also accessible at drop-in session through CN iPads.

2.3 Statistical accuracy

The statistical accuracy for a sample of this size is $\pm 5.8\%$ for a prevalence of 50 per cent at a confidence level of 95 per cent.

Example: If 50 per cent of respondents said 'yes' to a question that required a yes/no response, the true proportion of people in Newcastle who would give the same answer (if all participated) would be between 44.2 per cent and 55.8 per cent, 95 times out of 100 (see right hand column of table 1 for 50%-50%).

If 30 per cent of respondents said 'yes', the true proportion of people in Newcastle who would give the same answer would be between 24.7 per cent and 35.3 per cent, 95 times out of 100 (see 7th column of table 1 below for 30%-70%, ± 5.3% for a sample size of 300).

2.4 Drop-in session and survey promotion

The drop-in sessions and online survey were promoted via a paid advertisement in the Newcastle Herald and supported by a digital advertisement. A media release was distributed with information on the drop-in session locations, including session times and dates with links to a dedicated Have Your Say engagement webpage. Social media occurred reaching an over 14,500. Signage was also placed at several locations throughout the Newcastle local government area (LGA). An electronic invite was also sent to key stakeholder groups and promotion on CN's website homepage.

The majority of people who attended the drop-in sessions were broadly supportive of the project as a whole. Concerns that were raised by attendees were predominantly focussed on the inclusion of the skate bowl, specifically that it is proposed to be located on the beach.

2.5 Data handling

Data handling and analysis was carried out using Sparq software by CN's Community Engagement team.

2.6 Respondents

In total, 335 people completed the online survey.

3 Survey Findings

3.1 Overall support

The table below outlines how supportive survey respondents were towards the proposed plans for stage one of Bathers WayNewcastle project which included a wider shared pathway, new kiosk and amenities, progressive skate park and bowl, and a new community/recreational facility. The highest proportion of respondents 191 (57%) indicated that they opposed the proposed overall plans. A total of 139 participants (42%) indicated overall support.

3.2 Which aspects most strongly supportive

Participants who indicated that they either supported, or neither supported or opposed, the plans were asked to indicate what aspects they were most strongly supported (n=143). These results are provided in figure 1.

Participants could also nominate an 'other' open ended response. These are provided verbatim in Table 3.

Note: participants could select more than one option, therefore the results do not add to 100%.



Figure 1 Aspects most strongly support (multiple-choice)



3.3 Which aspects most strongly oppose

Participants who indicated opposition, or neither supported or opposed the plans were asked to indicate what aspects they were most strongly opposed (n=195). These responses are provided in Figure 2.

Participants could also nominate an 'other' open ended response. These are provided verbatim in Table 4.

Note: participants could select more than one option, therefore the results do not add to 100%.

Figure 2 Aspects most strongly opposed (multiple-choice)



No concrete bowl on the beach





3.4 Skate park concerns

The survey participants who stated they opposed the skate bowl and/or skate park (n=188), were asked what aspects of the skate park/bowl they were most concerned about. These results are provided in Figure 3.

Note: participants could select more than one option, therefore the results do not add to 100%.

3.5 Aspects of surf pavilion

Participants were asked to rank six aspects of the proposed redevelopment of the surf pavilion in order of importance (1 to 6), with 1 being the most important and 6 being least important.




Figure 2: Ranked aspects of surf pavilion by importance

These results are provided in Figure 2 and indicate that:

- Public amenities (toilets, showers, bubblers) was ranked as most important by the highest proportion of participants (30%)
- Shade and shelter was ranked as most important by 25 per cent of participants
- Provision of community facilities (includes surf life saving facilities) has ranked as most important by 24 per cent of participants



- Accessibility was ranked as most important by 16 per cent of participants
- Access to food and beverage services was ranked as most important by two per cent of participants
- Seating was ranked as most important by two per cent of participants.

3.6 Surf pavilion services and amenities


Respondents were asked to rank the provision of specific services and amenities of the proposed redevelopment of the surf pavilion (Bathers Way Newcastle – Stage 2) in order their level of support (1 to 6), with 1 being the most supportive and 6 being least supportive.

These results are provided in Figure 5 and indicate that:

- Kiosk/café was ranked as most important by the highest proportion of participants (35%)
- Youth and community space (e.g. space for local board-riding, surf or skate clubs) was ranked as most important by 29 per cent of participants
- Multi-purpose space which is available for community and event hire was ranked as most important by 22 per cent of participants
- Restaurant/bar was ranked as most important by 11 per cent of participants
- Recreational equipment hire or sale (e.g. surf/skate shop for equipment hire or repair, bike or scooter hire etc.) was ranked as most important by three per cent of participants.


